TAIPEI, Taiwan and MILPITAS, Calif., February 1, 2021 – Silicon Motion Technology Corporation (NasdaqGS: SIMO)("Silicon Motion" or the "Company"), a global leader in designing and marketing NAND flash controllers for solid state storage devices, confirms today its quarterly cash dividend.

On October 26, 2020, the Board of Directors of the Company declared payment of an annual dividend of US\$1.40 per ADS¹, equivalent to US\$0.35 per ordinary share, which will be paid in four quarterly installments of \$0.35 per ADS, equivalent to US\$0.0875 per ordinary share.
